INVITATION FOR BID (IFB) PROCUREMENT OF NCBs AND ICBX DIVERSE CONTRACT PACKAGES

INVITATION TO BID

The Ministry of Transport (MOT) was established by an act of legislature to administer all activities related to oversight responsibilities for the execution of policies relating to land, sea and air transport services operating within the country. It is also mandated to ensure strict adherence to insurance standards and regulations in collaboration with insurance agencies operating in Liberia.

1. The Government of the Republic of Liberia through the Ministry of Transport intends to apply part of its budgetary allocations for FY 2025 for the procurement of **diverse contract packages ranging from the code budget and the National Road Fund (NRF) project funds.**
2. The Ministry now invites sealed bids from eligible registered bidders for the supply of good and services and implementation of works, for Fiscal Year 2025 as stipulated on the table below.
3. Bidding will be conducted through the **NATIONAL COMPETITIVE BIDDING (NCB) as well as an INTERNATIONAL COMPETITIVE BIDDING (ICB) PROCESSES as it relates to the methods and contract packages involved based on** Procedure as enshrined in the Amended and Restated Public Procurement and Concession Act of 2010.

Both the **NATIONAL COMPETITIVE BIDDING process and the INTERNATIONAL COMPETITIVE BIDDING PROCESS** are opened to all eligible Bidders who shall have their origin in eligible source countries, as specified in the ITB Clause 3.1

6. A complete set of bidding documents in **English** may be purchased by interested bidders upon payment of a non-refundable fees of **100.00 USD for the NCBs and a fee of \$200.00 USD for the ICBs** to the Procurement Unit at the Ministry of Transport; between 10:00 am to 3:00 pm daily, and obtain a complete set of bidding document.
7. Prospective bidders must submit one original and three copies. Original bid must be enclosed in a sealed envelope and marked “**ORIGINAL**”. The three copies and the original copy must be enclosed in one large envelope and **labeled the name of the contract package and package code as would be indicated in the Bid Documents** and must be submitted to the below address. Additional details are provided in the Bidding Documents.
8. Sealed Bids must be delivered to the Procurement Unit beginning the date of submission, **April 1, 2025** not later than 10:00Am on Tuesday, **May 1, 2025 for NCBs and Tuesday, May 15, 2025 for the ICBs**. Please note that late bids will be rejected and returned to bidders unopened. Bids will be opened in the presence of bidders who choose to attend or their representatives on Tuesday, **May 1, 2025 for NCBs and Tuesday, May 15, 2025 for the ICBs or as may be adjusted in the Bid Documents. Bid opening will take place** in the conference Room of the Ministry of Transport.
